- 1) The Rules mentioned in Information Brochure of First Year undergraduate courses for Academic year 2023-24 or displayed by state common Entrance Test cell , Govt of Maharashtra will be followed (Refer Rule No.13) attached with the notification.
- 2) The Fees structure for this spot round shall be as attached with the notification.
- 3) Interested candidates are directed to refer to the link given on the college website www.gcoey.ac.in and register their names online along with registration form and registration fees of Rs.700/-.(Rs.Seven Hundred Only). Only registered candidates will be considered for the 'Institute Level counselling Round'. Link for Registration will be available on Web Portal of Institute as per Schedule mentioned in this notification.
- 4) **ONLY THOSE CANDIDATES WILL BE ELIGIBLE FOR THIS ROUND, WHO WILL REGISTER ONLINE.** (Offline registration will not be entertained in any case.)
- 5) **The processing fees Rs 700/- (For all categories) should be paid through SBICollect to 'PRINCIPAL GOVT. COLLEGE OF ENGG. YAVATMAL' under the head 'Processing fees'. After successful payment upload the receipt to the form which is mandatory.**
- 6) Documents Required for Admission; if seat is offered:
 - a) Print out of Final seat allotment letter or if seat is not allotted then final merit Status for Admission which mentions Application ID and State General Merit Number issued by State Common Entrance Test cell, Government of Maharashtra
 - b) All original documents of certificate as listed in Receipt cum Acknowledgment. If original documents are already submitted to any other institute, Candidate has to produce certificate of document retention and Xerox copies of document as listed in receipt cum Acknowledgment; duly signed by Principal of institute in which admission is already taken.
- 7) **Procedure of Counselling Round :-**
 - a) Registered candidates must report **personally** at the scheduled date and time at the venue of the admission center in the institute.
 - b) All admissions will be strictly as per the Inter-se- Merit declared by state common Entrance Test cell, Govt.of Maharashtra
 - c) Candidates will be called as per Inter-se-Merit number. If the candidate is absent or does not report for admission when his/her name is called; he/she will lose the claim for Admission. If the Candidate is present and if the vacant seat is offered to the candidates as per Inter-se- merit, and if candidate is willing to seek the admission to the offered seat, candidate has to pay entire admission fees as applicable by online mode only (Net banking, Credit card or Debit card/ etc) immediately on the spot. If the Candidate fails to pay the entire fees he/she may lose the claim of admission for the offered seat and the same seat will be offered to the next candidate as per inter-se-merit
 - d) If any candidate who has been already admitted in Government college of Engineering, Yavatmal and seeks admission in counselling round to other branch, he/she has to cancel his/her prior admission by paying Rs.1000/- as cancellation charges. Such candidates have to pay applicable fees. The Cancelled seat of this institute will be made available to next candidate as per inter-se-merit, for admission during this counselling round.

- e) The tentative vacancy position will be displayed at the time of the start of the counselling round. This being a dynamic round, the vacancy position for each branch may vary during the round.
- f) The admitted candidate will have to submit all requisite original documents before the date given by the institute failing which the given admission may be cancelled.
- g) Venue for the counselling Round is 'Civil Engg. Department' first floor, Civil Engg. Dept building of the Institute.

RULE 13.

Admissions in Institutional Quota and vacant seats after CAP.- The Director or Principal of the institution shall carry out the admissions for these seats in the following manner. –

(a) Admissions shall be made in a transparent manner and strictly as per the Inter-Se-Merit of the Candidates who have applied to the Competent Authority for verification of documents and then to the Institution.

(b) Information brochure or prospectus of the Institution which specifies rules of admission should be published well before the commencement of the process of admission. All the information in the brochures should also be displayed on the Institution's website.

(c) Institution shall invite applications by notifying schedule of admission and the number of seats in each course to be filled by the institution, by advertisement on the website of the institution.

(d) Aspiring Candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall apply to the Principal or Director of the respective institution for admission at the Institution level as provided in rule 3(4)(b) and shall be filled in on the basis of Inter-Se-Merit prepared by following the procedure specified in 8(3).

(e) The institution after verification of all required documents shall prepare and display the InterSe-merit lists of the Candidates to be filled in at the institution level, in the Institutional Quota and Supernumerary Quota of OCI / PIO, Foreign National, Children's of Indian workers in Gulf Countries along with the vacant seats after CAP, on the notice board and shall publish the same on the website of the institution.

(f) The Minority or Non-Minority institution intending to surrender the Institutional Quota (in part or full) of specified courses to the CAP shall communicate two days before the display of seat matrix of CAP Round I and the same shall be allotted as per the rules of CAP. The Institutes shall not be allowed to surrender Institutional quota seats thereafter.

(g) All the admissions and cancellations shall be updated instantly through online system.

(h) If any CAP seat remains or becomes vacant after the CAP Rounds, then the same shall be filled in by the Candidate from the same Category for which it was earmarked during the CAP. Further if the seats remain vacant then the seats shall be filled on the basis of Inter-SeMerit of the applicants. (i) While filling these seats the preference shall be given to Maharashtra State Candidature Candidate over All India Candidature Candidate on the basis of Inter-Se-Merit.

(j) After exhausting Maharashtra State Candidature Candidate and All India Candidature Candidate, if any seat remain vacant in the Sanctioned Intake then these seats may be filled with NRI, Foreign Students (FS), Overseas Citizen of India (OCI), Persons of Indian Origin (PIO), Children of Indian Workers in the Gulf Countries (CIWGC) Candidature Candidates, if the institute has secured prior approval from appropriate authority for these seats.

STEPS TO FILLING THE ONLINE FORM

- 2) The processing fees Rs 700/- (For all categories) should be paid through SBI Collect to 'PRINCIPAL GOVT. COLLEGE OF ENGG. YAVATMAL' under the head 'Processing fees'. After successful payment. Be ready with receipt copy.
- 3) Click on the link displayed on the portal www.gcoey.ac.in
- 4) Fill up the information carefully
- 5) Fill up the SBI Reference No. (Which is mandatory)
- 6) Upload the SBI payment Receipt (Which is mandatory)
- 7) Download the application form.
